ABSTRACT: This work aims to describe the main contractual instruments in the hydrocarbon sector, presenting an overview of the state of the art in Mexico. As a secondary objective, it intends to provide readers with a better understanding of the Mexican legal situation.

I. INTRODUCTION

The¹ oil & gas industry is international by nature: international contractors, multinational companies, overseas logistics, mergers and acquisitions from different countries, multinational suppliers, global investors, transboundary reservoirs, you name it. Nonetheless, the Mexican oil & gas industry used to have a very limited participation in the international arena due to its legal framework. The Mexican oil & gas industry used to participate in the international arena exclusively in the commercialization phase, and incidentally in legal proceedings before courts in the United States of America.

A decade ago, in 2013, the Mexican oil & gas industry became international by nature because the legal regime was modified. The Mexican hydrocarbon contracting regime has been modified and improved over time and has been adjusted to international standards. These changes encompass a process of unification criteria to have a Mexican internal system which is now, standardized to international practices.

It is in this regard that the authors have proposed to present an exercise, fundamentally descriptive and synthesized of the contractual practices related to the hydrocarbons industry, understanding that a mixed scheme of public and private law is in place,

different scenarios with so many variants with respect to the general regime, that simply analyzing this point may well be the object of a whole different study¹⁸⁹.

Reiterating the above, the hydrocarbons sector is a complex issue with multiple edges, both in terms of economic policy, in an environment such as the Mexican one, and also with an important symbolism in the political and social sphere, given Mexican historical transition and a complicated model of administrative regulation idiosyncratic, characterized by a high level of regulation, both legislative and administrative, and therefore, makes it a legal phenomenon that is difficult to address.

Finally, since it is a complex market, beyond the development of the internal regulation on the matter, it will be the market that will impose the best practices and general rules for the execution of contracts in the sector related to the exploitation of hydrocarbons (regardless of the contracting regime of its more traditional administrative practice), and it will be the State's responsibility to adapt its regulation in this regard in such a way that the existing regulations do not lose their validity and do not conflict with such standards.


